## Rebuilding spring tornadoes

Devastating tornadoes swept across the southeast in the spring of 2023 and 2024, destroying homes, displacing families and taking lives. Two particular storms led to notable destruction in Maury Regional Health's service area, including Maury and Wayne counties.

The Beech Creek Community Center and Fire Hall in Wayne County was among the wreckage caused by the F3 tornado in spring 2023. In response, the Foundation donated \$5,000 toward the reconstruction of the community's only local fire service.

"We are tremendously grateful for the support of the Maury Regional Health Care Foundation," said Sherry McDonald, a Waynesboro resident and volunteer leader. "Our community is rural, but they deserve to have first responders close by. Our rebuild has been slow but steady as we look to not only rebuild our facility, but we're also setting up the Wayne County Outreach initiative to support action planning for any future emergency events."

Following the tornado in spring 2024, the Foundation also provided \$1,000 stipends to two Maury Regional Health employees who experienced damage to their homes as well as \$1,025 to the City of Columbia in their efforts to assist the community as a whole.

## **Coming in hot** and keeping it cool

To combat the extreme weather this year, Maury Regional Health's mobile unit hit the road to keep people cool in climbing summer temperatures and to provide warmth in recordbreaking winter weather conditions.

Intense winter or summer weather conditions are difficult for all but can have an especially dangerous impact on unhoused community members.

"Safety is always a concern in extreme temperatures," said Lori Bergland, RN, community health coordinator for the mobile unit. "These cooling and warming stations offer relief, shelter, fellowship, hydration and food. I'm very grateful for the donations to the Foundation that allow us to provide this life-saving support for communities in need."

The mobile unit has also partnered with local organizations to assist our unhoused population with finding places to stay safe during dangerous weather conditions. In 2023, The Family Center opened their doors to offer heated locations for seven snowy days for more than 100 guests, with the support of volunteers from Maury Regional Health and our community.



# Making Waves

#### **Sponsored swimming** lessons for Maury County youth

Did you know that if someone doesn't learn to swim as a child, it is unlikely they will learn in their lifetime? And that drowning is the leading cause of death for children ages one to four?

This year, the Foundation took an exciting plunge into community health by sponsoring swimming lessons for more than 70 children during a week-long camp during fall break. The program was facilitated by Muletown Rec in partnership with the Boys & Girls Clubs of

South Central Tennessee.

"Muletown Rec, who developed the curriculum, is uniquely suited to engage our community's youth," said Boys & Girls Clubs CEO Ginny Wright. "This effort not only supports families with limited accessibility to aquatic programming, but it fosters an education and

respect for water,



creating a ripple effect for years to come."





# Prescribing Hope

### **Foundation partners with The Family Center** to provide medication assistance

For more than 15 years, the Maury Regional Health Care Foundation has partnered with The Family Center to provide critical support to individuals in need of medication assistance, improving the health outcomes of Maury County residents.

The Family Center's medication assistance program — with support from the Foundation — is designed to support low-income individuals struggling to afford prescriptions for chronic conditions, such as diabetes. By covering essential medication costs, The Family Center helps community members receive the care they need, without the financial burden.

"We are incredibly grateful to the Foundation for their invaluable support in sustaining our medication assistance program," said Dawn Taylor, executive director of The Family Center. "Many of our clients face difficult choices between paying for their prescriptions or other basic needs, and this program provides them with the relief they need to be stable and healthy."

To participate in the medication assistance program, individuals must apply through The Family Center. If approved, they will then transfer their prescriptions to a designated pharmacy in Columbia where their prescriptions will be filled. This does not cover narcotics or painkillers and has an annual limit of \$250.

"The Family Center's dedication to meeting the health and well-being needs of our community aligns with our mission," said Patrick Harlan of the Foundation. "By supporting their medication assistance program, we're helping our community stay healthy and prevent or manage serious illnesses."

Founded in 1994, The Family Center is celebrating their 30th anniversary this year. They are a long-standing nonprofit that takes a holistic approach to supporting their community, aiming to enhance stability and health. Over the years, it has evolved into a multi-faceted organization addressing various community needs — especially during times of economic hardship and in support of children and the unhoused population. In addition to medication assistance, they offer a variety of programs that range from providing financial support for rent or utilities to assistance with food, eyeglasses and more.

The Maury Regional Health Care Foundation's Special Needs Fund supports not only programs like The Family Center but also provides medication, medical supplies and gas cards for Maury Regional Health patients experiencing financial need.

## **Established Funds**

When you make a donation to the Maury Regional Health Care Foundation, you're helping to break down barriers and improve access to vital community health services.

- Community Health/Mobile Unit Fund: provides resources to assist with unmet health care needs of underserved or uninsured populations, including the mobile medical unit
- Friends & Family Nutrition Fund: provides meals to a patient's primary support member while in our care and assists in funding a food pantry that provides groceries to those in need upon discharge
- Special Needs Fund: provides medication, medical supplies and gas cards for patients experiencing financial need
- Dr. Maura Lipp Palliative Care Fund: assists Maury Regional Health's palliative care program in meeting the unique needs of those facing chronic illnesses
- Focused Care Areas: provides supplies, support and transportation for the Cancer Center, Women's Center and the Cardiology, Diabetes, Neonatology and Pediatric departments
- The Retreat Fund: operates a hospitality home for cancer patients
- · Wayne Medical Center Fund: assists patients and employees of this facility experiencing financial need
- William R. Walter Employee Assistance Fund: assists Maury Regional Health employees who have experienced an unexpected crisis or who are pursuing continuing education
- Dr. Eslick Daniel Youth Health Initiatives Fund: provides educational materials and resources for projects improving the health of youth
