The Express Care Clinic for MRH employees is now exclusively using the QuickCharge payroll deduction system

About QuickCharge

Last year, Maury Regional Health (MRH) introduced QuickCharge, which allows employees to scan-and-go by paying with their payroll deduction, eliminating the need to carry cash or cards. This benefit is available at select MRH locations, including dining locations, pharmacies, gift shops and now the Express Care Clinic.

Setting up QuickCharge

Before employees can swipe-and-go with QuickCharge, they must first submit an authorization form in their infor account under My Profile > QuickCharge.

Once employees have authorized use of the payroll deduction system, a spending limit of \$300 for full-time employees and \$200 for part-time employees will be in place for each pay period. PRN employees may only use QuickCharge in the Express Care Clinic.

Our new IT Help Desk is here!

In an effort to modernize, automate and make your interactions with IT more efficient, Maury Regional has launched their new, user-friendly IT help desk portal that features custom widgets to assist internal customers.



The Express Care Clinic requires QuickCharge

The Express Care Clinic is just like it sounds - a clinic for employees! With a \$25 per visit fee, employees can seek treatment for minor illnesses, physicals, x-ray



imaging and other primary care services. The clinic is located on the Maury Regional Medical Center campus and, effective immediately, will exclusively require payment to be made through QuickCharge by scanning their ID Badge.

Note: Payment is not required for employees seeking care for work-related injuries or illnesses at Employee Health.

System features include automated updates for requests and a resource library where users can browse policies, FAQs and learn how to fix issues independently. The new platform will also replace prior online forms, enabling users to process the following requests, including but not limited to new equipment and software licensing.

Due to the new user-friendly portal, we've eliminated the ability to email tickets into our system. We encourage you to utilize the portal as we continue to develop a comprehensive template for entering tickets. Please note that all emails coming from the new system will show up as "MRH IT Support." The Maury Regional Health Outpatient Pharmacy is pleased to announce the launch of our new pharmacy mobile app: Rx365.


Features of the new app include the ability to:

The pharmacy is open Monday-Friday from 7 a.m. to 5 p.m.
